Any failure to make this proof of currency available may cause forfeiture of any funds previously paid at the discretion of the management committee in order to cover administration. Proof of Currency may be attached to this application or presented upon arrival.

Workplace Health & Safety Policy:

Any exhibitors intending to bring equipment to the showgrounds will be required to ensure that such equipment is fitted with earth leakage circuit breakers and that all electrical leads, tools and appliances have been inspected and tagged by a licensed electrical contractor. This is essential for the safety of all exhibitors and the general public as is a requirement of the Work Place Health and Safety Act of 1989. The Act imposes very severe penalties in the event of non-compliance with its provisions. Any exhibitors who do not comply will not be allowed to exhibit at the Kalbar Showgrounds. Exhibitors should check all electrical equipment and leads before coming to the Showgrounds to avoid the occurrence of any difficulties.
