RULES & REGULATIONS

1. All competitors must pay Gate admission fees.
2. All exhibits are to be in place by 4.00pm Thursday, June 23rd 2017.
3. All exhibits must have been completed in the last 12 months. Work recognized as being over 1 year old will be classed as non-competitive.
4. All exhibits must have included the exhibitors name and class in which they are entered.
5. Judging to commence at 10:00am on Friday, June 24th 2017.
6. **Exhibitor Points Calculation:**
 - Any First Place - 3 points,
 - Any Second Place - 2 points
 - Any Third Place - 1 point.
 - Any Champion – 3 points.
 - Any Reserve Champion – 2 points
7. Prize Money may be picked up after 4:00pm on Saturday, June 24th 2017.
8. The Society will provide greatest care but will not accept any liability for items exhibited, the risk being that of the exhibitor.
9. Electrical Equipment- Any exhibitors intending to bring electrical equipment and or gas bottles to the showground's will be required to ensure that such equipment is fitted with earth leakage circuit breakers and that all electrical leads, tools and appliances have been inspected and tagged by a licensed electrical contractor or gas fitter. This is essential for the safety of all exhibitors and general public and is a requirement of work place health and safety act of 1995. The act imposes very severe penalties in the event of non compliance with its provisions. Any exhibitors who do not comply will not be allowed on the Kalbar showground's. Exhibitors should check all electrical equipment and all gas bottles to avoid occurrences of any difficulties

Declaration of Event Participant

1. I hereby acknowledge that it is a condition of participating in the event that I do so at my own risk.
