## **CHERRY BAR CAKE**

### **OPEN SECTION CLASS 6**

4 ozs(125gm) Butter	4 ozs(125gm) Sugar
2 Eggs	Vanilla
½ cup Milk	8 ozs S.R.Flour
½ cup Cherries cut	

Beat Butter and Sugar to a cream, add eggs one at a time and beat well, then add vanilla, sift flour and salt together, and add to mixture alternately with milk, then mix in cherries, Pour into a greased and floured loaf tin. Bake in a moderate oven for approximately 40 minutes, let cool then ice with plain icing.
