1. No exhibit may be entered in two distinct classes.
2. All exhibits to be judged by appearance.
3. Fruit & Vegetables to have stems left on.
4. **Exhibitor Points Calculation:**
  - Any First Place - 3 points,
  - Any Second Place - 2 points
  - Any Third Place - 1 point.
  - GRAND CHAMPION EXTRA 3 points
  - RESERVE CHAMPION EXTRA 2 points
  - HIGHLY COMMENDED EXTRA 1 point
5. All exhibits in this section must be delivered no later than 8:30am on Friday, 21<sup>st</sup> June 2019.
6. **Junior Section:**
  - **Exhibitors MUST be aged between 2 and 15 years of age.**
  - **One Entry allowed in each class per exhibitor**
7. Prize Money may be picked up after 3:00pm on Saturday, June 22<sup>nd</sup> June 2019.
8. The Society will not accept any liability for produce exhibited, the risk being that of the exhibitor.
9. Electrical Equipment- Any exhibitors intending to bring electrical equipment and or gas bottles to the showground's will be required to ensure that such equipment is fitted with earth leakage circuit breakers and that all electrical leads, tools and appliances have been inspected and tagged by a licensed electrical contractor or gas fitter. This is essential for the safety of all exhibitors and general public and is a requirement of work place health and safety act of 1995. The act imposes very severe penalties in the event of non-compliance with its provisions. Any exhibitors who do not comply will not be allowed on the Kalbar showground's. Exhibitors should check all electrical equipment and all gas bottles to avoid occurrences of any difficulties
