- An exhibit in this section cannot compete in more than one class.
- ALL CATTLE TO BE HORN TIPPED EXCEPT VEALER CLASSES
- No competitor permitted to enter judging area while judging is in progress (unless they are a steward)
- Any exhibit found to be incorrectly entered may be transferred at the discretion of the stewards.
- Cattle not accompanied by a fully completed current NVD will be refused entry.
- All cattle to be offered for sale, if passed in commission to be paid on last bid
- Entries close 6:00pm Thursday 19th June 2025
- All cattle to be penned by 5:00pm Friday 20th June 2025
- Judging to commence 8:00am Saturday 21st June 2025
- Sale to commence 1:30pm Saturday 21st June 2025. (GST is added at fall of hammer where applicable to cattle)

National Livestock Identification System (NLIS) PIC# QHBN1637

All cattle traveling to the Kalbar Showgrounds MUST have an NLIS device applied before leaving property of origin (this includes calves)

All cattle present at a Show much have the individual identifications read and the movements to and from the site recorded on the Showgrounds Property Identification Code (PIC) in the database.

SECTION A: SUPPLIER'S STATEMENTS ABOUT RISK AND DUTY OF CARE

- Physical competitions and activities, Events and use of the Suppliers' facilities are all dangerous recreational activities.
- This document is a risk warning for the purpose of the Civil Liability Act (2003) QLD and Australian Consumer Law. Any and all warranties, conditions and guarantees in relation to the competitions and activities, Events and use of Suppliers' facilities which are implied by Australian Consumer Law are excluded to the fullest extent permitted by law.
- This risk warning is given by or on behalf of the Suppliers.
- This document acts as an exclusion of liability under the Civil Liability Act (2003) QLD if the services supplied by the Suppliers are supplied without reasonable care and skill.
